MILITARY FRIENDS DEDICATES \$100,000 TO “MASSACHUSETTS CARES!” GRANTS
New Grant Pilot Program to Benefit Deployed Mass. Guard & Reserve Families

(BOSTON) - The Military Friends Foundation, a non-profit organization chartered by the Commonwealth with caring for Massachusetts Citizen Service Members, was joined by Military Families and Government Leaders at the State House today to announce a new pilot program to recognize families of deployed Massachusetts Guard and Reserves. The “Massachusetts Cares!” Grant pilot program will receive \$100,000 from the Military Friends Foundation.

“The Massachusetts Cares! Grant is a ‘Thank You’ to those who are putting their lives on the line in service to our country,” said **Sergeant Major Jim Kelly (Ret.)**, President of the Military Friends Foundation and an Iraq veteran who served with the Massachusetts National Guard. Sergeant Major Kelly said the grant will help deployed service members and their families. “I can tell you first-hand that it is not just the service member who is impacted by deployment – in a very real way a family serves as well. The Massachusetts Cares! Grant recognizes that service.”

Massachusetts Cares! will provide \$200 grants to deployed E-7s and below who, like so many, face financial challenges during their deployment. “Each Mass. Cares! grant represents a contribution to the lives of our military families...it can be another week of camp for a child, groceries for a week or simply the opportunity to speak with a beloved military member with the peace of mind that comes from knowing your neighbors care for you,” said **Major General Joseph C. Carter, Adjutant General of the Massachusetts National Guard** to military families and supporters in attendance.

Joining the Military Friends Foundation at this launch was **Lieutenant Governor Timothy Murray** “As Massachusetts continues to be a national leader in offering comprehensive benefits and services to our service men and women, I want to congratulate the Military Friends Foundation for finding an innovative way to provide financial assistance to our military families through the Massachusetts Cares Grant,” said Murray, who also serves as Chair of the Governor’s Advisory Council on Veterans’ Services.

will encourage family and friends to check off the Voluntary Contributions in the future. I know that any amount will benefit our military families.” Specialist Lynn of Quincy is serving a tour of duty in Afghanistan.
